FREQUENTLY ASKED QUESTIONS

WHAT IS CLEARSKIES?

*clear*Skies is an independent emissions and energy performance certification mark for solid fuel stoves. *clear*Skies is a UK-wide programme to help **lower** emissions and **improve** air quality. It builds on Ecodesign which came into force on 1st January 2022 by demonstrating a stove meets and exceeds the minimum standards.

WHAT IS A CLEARSKIES CERTIFIED STOVE?

*clear*Skies certified appliances meet the minimum performance level for Ecodesign regulations – the minimum legal requirement for an appliance manufactured in the UK from 1st January 2022. *clear*Skies stoves are sorted into 4 levels and the different levels allow you to identify how far beyond Ecodesign criteria they go in terms of reducing emissions and increasing efficiency. Most Charnwood products carry a level 5 certification which mean they are at least a 30% performance improvement on the minumum Ecodesign criteria, the highest level available.

WHAT ARE THE KEY DIFFERENCES BETWEEN NON COMPLIANT STOVE AND A CLEARSKIES STOVE?

*clear*Skies products have to meet a set of clean-burning criteria. Research has shown that an Ecodesign stove is at least 90% better than open fire and 80-84% better than older stoves. Take a look at the table on the previous page; these figures are achieved by advanced air management. Charnwood have developed an ultra clean burning BLU technology that ensures more heat for less fuel while reducing smoke and emissions.

HOW WILL THE PERFORMANCE OF MY STOVE BE AFFECTED?

A *clear*Skies Charnwood BLU model will burn less fuel more efficiently with a **better** flame picture.
